Minutes of Stonehouse Neighbourhood Development Plan Working Group held on 3 November 2016

3. Accuracy of the minutes and Actions:

The minutes of the Neighbourhood Development Plan (NDP) Working Group of 15 September 2016 and 5 October 2016 were approved.

Outstanding actions and actions not within agenda:

ACTION: RR to prepare folders on the Google drive so Town Councillors have access to range of information regarding submission draft or to direct Town Councillors to website where appropriate.

4. Project Progress

a) Budget and finance

RR reported there had been an invoice from S Todd re policy redrafting for £219.99 (excluding VAT) to be taken from Town Council NP consultancy support budget of £1,500. A budget report was provided and is attached as Appendix 1 to these minutes. All of the current Locality Grant must be spent by 30 November 2016. Consultant for Health Check (final item to be funded by Locality Grant) has been appointed.

RR reported there are now 6.25 hours of GRCC time left.

DECISION: GRCC to be asked to invoice for all the time in their quote of April 2016; the 6.25 hours will be in hand for future advice.

NP Re-design costs: The NP draft will need to be redesigned for submission and then for referendum. There is £529 of the previous Locality Grant unaccounted for which could be spent on this. It is possible some of the Town Council NP consultancy support budget could be used for this if necessary.

b) Project timetable

Mid November Conditions statement to be ready, after Health check complete.

21 November Submission draft of Neighbourhood Plan and all supporting documents to be

circulated with papers for Town Council meeting of 28 November.

Consultation responses: RR suggested that a final version of the SNPG response to consultation representations should be put on the website.

ACTION: RR to ask CK to prepare final version of collated response table.

Heath Check on submission draft of Neighbourhood Plan

VR, CK and CS shortlisted six consultants to approach regarding the health check. RR contacted and John Slater was the only consultant available. He has been appointed and is ready to start week beginning 7 November. His rate is the same as the NPIERS service.

6. Pre Submission draft

- a) DECISION: The advice from Stuart Todd, Planning Consultant, on three Neighbourhood Plan policies (AF1, AF3 and H6) was accepted and the draft NDP will be amended accordingly.
- b) **DECISION:** It was agreed that the pre-submission draft of the Stonehouse Neighbourhood Plan to be sent to planning consultant for health check will consist of the consultation draft edited in line with the consultation responses already agreed by SNPG and with S Todd's advice of 25 October 2016.

Theme leaders and Administrator have edited the consultation draft in line with agreed consultation responses as follows:

Transport (CK), Housing (RR), Employment (AS), Environment (RR), Priority Projects (CK)

ACTION: VR/RR to edit Amenities and Facilities and Housing sections in line with S Todd's advice.

ACTION RR: to collate all section edits into one pre submission Stonehouse NDP draft to be sent to John Slater.

7. Supporting documents for submission to District Council with Neighbourhood Plan DECISION: The submission draft of the Neighbourhood Plan will be submitted with: Consultation statement, Conditions statement and Town Character Assessment

Consultation Statement: RR has been working on this and asked for any details, records, dates and notes regarding some of the consultation events with results recorded in TW's Theme Team Consultation response spreadsheet, e.g. British Legion, Rock Youth Club and three Schools events. TW and CS advised that there might be records of these events in SNPG minutes.

ACTION: RR to continue with work on Consultation Statement to be completed by 17 November 2016

Conditions Statement: RR might be able to do but it was agreed that some consultancy support (£1,280 of Town Council budget available) might be needed.

ACTION: RR to seek quote from S Todd for preparing Conditions Statement.

9. Neighbourhood Planning Regulations and Bill

RR reported that the Neighbourhood Planning Bill was now at Committee Stage. The Bill includes measures to make some modifications to a Neighbourhood Plan without the need to go to referendum on every change.

Neighbourhood Planning Regulations have been introduced that set a timetable for local authorities to meet when dealing with Neighbourhood Plans. Local authorities can no longer set referendum dates and associated deadlines for submission of Plans.

10. Any Other Business

Jo Byrne will join SNPG as a Town Council representative as Ginny Smart has resigned from Town Council.

RR reported that Ricardo Rios had phoned to say he will be leaving his post at Stroud District Council on 14 November to take up a role with South Oxfordshire. Ricardo advised that the Consultation or Conditions statement should include a section on meeting EU Obligations including Human Rights in relation to ensuring that there was a fair chance of a range of people influencing the NP. Ricardo will also be issuing a Screening Determination regarding SEA and HRA as currently he has only provided a Screening Opinion.
