Thank you for giving SDC an opportunity to comment on the emerging vision and objectives of your NDP.

We consider the NDP vision and objectives pick up on the main aspects identified in the Local Plan vision for the Stonehouse cluster.

One important point that we would raise, is that whilst employment and retail are given due consideration in the objectives, they are notable absences in the vision. In the our opinion, the role of Stonehouse as an employment hub and the quality of the retail facilities should be mentioned in the NDP vision.

The objectives are generally welcomed and considered capable of evolving into positive policies that add value and detail to local planning policies.

The document attached contains individual comments for each section. These comments have been based on feedback from independent examiners and mostly aimed at highlighting some of the expectations in relation to taking the vision and objectives forward.
